## STAGES OF ASPRI MEMBERSHIP APPLICATION



STEP  
1

### APPLICATION

- Choose the type of membership
- Fill up the respective e-form(s)
- Ensure that you have filled up every field
- You will receive an automatic email upon completion

2

### VERIFICATION

- ASPRI will process the information you have submitted
- Check your Glue Up to see the status of your application
- Corporate Membership process will take longer due to the layers of verification required

### PAYMENT

- Once your submitted documents are verified, ASPRI will e-invoice you along with the payment instructions
- Your application will only be submitted to our Membership Committee for approval upon receipt of payment
